### PREFACE

In 2019 we entered into our third year of IMPACT: Center against Human Trafficking and Sexual Violence in Conflict.

For us it was an exciting year in which we continued to work on the nexus between human trafficking and sexual violence in conflict. We organised the third edition of our Tilburg University Summer School and launched a special issue on the nexus. Also, in cooperation with Paris Legal Publishers, we set the first steps towards setting up the very first journal on this important theme!

We can also look back at some other important projects that underscore the impact we always intend to have, including on the impacts of litigation in relation to crimes committed by the Dutch military forces in the former colony the Dutch East Indies and on combatting abuses/exploitation of labour migrants in the Province North Brabant.

The book project "And I Live On" deserves some separate attention. At the Peace Palace, during an academic conference organised by the Rwandan Embassy in light of the 25th commemoration of the Genocide against the Tutsi, we were given the opportunity to launch the book "And I Live On: The Resilience of Rwandan Genocide Survivors of Sexual Violence", completing 1,5 years of work with a wonderful team from Toronto University. The voices of survivors about their own empowerment and resilience is the most powerful way of learning about the impact of support first-hand. Many activities followed to promote their resilience.

Our next move will be to have a book launch in Rwanda, with some of the survivors involved, and to set up an online educational platform on sexual violence in conflict.

We also took some initial steps to venture into the pressing theme of sexual terrorism, where terrorism, human trafficking and sexual violence in conflict meet. A topic which we will continue to work on in the coming years. So, there is still enough work ahead of us. For now, we wish to thank everyone who has supported our work for making it possible to make an IMPACT together!


# **Values**

#### Training & **Capacity Building**


Target group: professionals



# Research and advice

#### COLONIAL CRIMES

In 2018, we conducted research, on behalf of the Nuhanovic foundation, on the impact of litigation before Dutch civil courts in relation to the systematic and large-scale atrocities committed by the Dutch military forces in the former colony the Dutch East Indies between 1945-1949. On 12 November 2019, the report was finalized and presented by IMPACT during a seminar at the University of Amsterdam. Other presenters included Liesbeth Zegveld, Jeffry Pondaag, Wouter Veraart and Frederiek de Vlaming.






#### **OSCE Hospitality** and Tourism



In 2019, we conducted, on behalf of the OSCE, a background study on policies and practices regarding the travel and hospitality industry and combating trafficking in human beings. As one of the largest worldwide industries. it paramount to take measures to end human trafficking that are designed specifically for the sector. The background study consists of public initiatives (government, international organisations, nongovernmental or non-profit initiatives organisations), private (business and associations) and a mixture of both.



#### PROVINCE NORTH **BRABANT ON EXPLOITATION OF MIGRANTS**

In 2019, IMPACT, CoMensha Tilburg and University conducted a research on behalf of the Province of North Brabant, in order to increase the attention for abuses and exploitation among labour migrants in regional and local labour migration policies. consists of a labour market analysis and the current policy approach to tackle abuse and exploitation among labour migrants. It resulted in several recommendations/steps municipalities and other local be taken partners to to and tackle prevent abuses/exploitation.

#### Journal of Human Trafficking, Enslavement and Conflict-Related Sexual Violence

In 2019, we started with preparations - together with Paris Legal Publishers - to set up a new multi- and interdisciplinary journal on the nexus between human trafficking. enslavement and violence; conflict-related sexual themes which are up until now still largely underexplored, recognized by the United Nations. The Journal of Human Trafficking, **Enslavement and Conflict-Related** Sexual Violence (JHEC) aims to fill this gap by researching both the nexus between these crimes and studying the crimes individually. JHEC will become operational as of early 2020.

#### ISZW 2019 – Decent Work

At the end of 2019 we started with the implementation of several activities to contribute to realizing decent work in the Netherlands, as a way of preventing and responding to labour exploitation of migrant workers. This includes drafting a code of conduct about decent work to be used when guiding migrant workers to decent work, sensitizing the Social and Economic Council of the Netherlands (SER) to speak out for decent work as the norm in the Netherlands, and experiment with mediation of former victims of trafficking recruitment to agencies/businesses under these decent work conditions. project is executed on behalf of and in cooporation with the Dutch Coordination Center against Human Trafficking (CoMensha), that had received funding from the **Dutch Ministry of Social Affairs and** Employment (SZW).



#### Several Research **Projects**

In 2019, we participated in several research projects, including: (1) article (with writina an C. Paulussen) on the nexus between terrorism, conflict-related sexual violence and human trafficking for sexual exploitation ("sexual terrorism") with case studies on Boko Haram and Al-Shabaab for the Journal of International Criminal Justice (with publication in 2020); (2) writing an article (with Mama Lambert) on the resilience of Rwandan Genocide Survivors of Sexual Violence based on the book And I Live On

(with publication in 2020); (3) publication of our guest-edited special issue on "the nexus between conflict-related sexual violence (CRSV) and trafficking in human beings (THB) for sexual exploitation in times of conflict" for the Journal of Trafficking and **Human Exploitation (Paris Legal** Publishers), including our own article on "the nexus between conflict-related sexual violence trafficking for sexual exploitation in times of conflict (with R. Ghafoerkhan and W. Scholte): (4) supervising and students from Strathmore University (Nairobi) in writing their theses.



#### Presentations and Participations in Conferences

In 2019, we held several presentations and participated in events, including during: (1) a panel discussion for the International Day for the Elimination of Sexual Violence in Conflict at Leiden University, Campus The presenting on the experiences of Rwandan genocide survivors of sexual violence during the "Call it what it is: Translating the lived experience of sexual violence survivors into law" panel, organized by the Women's Initiatives for Gender Justice (19 June 2019); (2) the International Conference on "Mental health and psychosocial support in crisis situations", organized by the Dutch Minister for Foreign Trade

Development and Cooperation, Amsterdam (7-8 October 2019); (3) the Congress of the International Mukwege Chair, presenting (with Mama Lambert. counselor of genocide survivors in Rwanda with Solace Ministries) "Children born on genocidal sexual violence: The Impact of study counselling A case from Belgium Rwanda". in Liège, (13-15)November 2019), (4) the Global Convening on Trafficking in Women in Global the Context of Migration organized by International Women's Rights Action Watch Asia **Pacific** (IWEAW Asia Pacific), the Global Alliance Against Traffic in Women (GAATW) and FEMNET, in Nairobi, Kenya, presenting on "Improving access to justice with a particular focus on compensation within Europe" in the "access to justice" panel (2-4 December 2019).



# EDUCATION & **AWARENESS**

Accreditation of IMPACT as Certified Educational Institute

In 2019, we were accredited as **CRKBO-Institute** ("Centraal Register Kort Beroepsonderwijs"). This means that we are officially recognized as an institute that qualifies for providing a certain standard of quality with regard to education.

Course 'Criminal **Justice Systems'** at University of Amsterdam

In the first half of 2019, we taught the course 'Criminal Justice Systems' for Amsterdam University College (University of Amsterdam). The course dealt with the similarities and differences among the different criminal justice systems worldwide, in particular across countries, regions and international criminal tribunals.

#### Webinar on Conflict-Related Sexual Violence

In May 2019 we gave a webinar on the topic of conflict-related sexual violence and its international criminal prosecution to students from Tehran University, Iran.



#### **Summer School at Tilburg University**

In July 2019, we taught for the third time our two-week Summer School course at Tilburg University on preventing and addressing conflict-related sexual violence and human trafficking for bachelor/master students from all over the world and of any discipline. During these two weeks the opportunities and challenges in addressing both crimes were discussed from both a theoretical and practical perspective. The course also included group assignments and visits to the International Criminal Court and the Utrecht Military Base for an interactive seminar on human trafficking and human smuggling in relation to the current EU migration crisis.


## Workshop Group Dynamics

In 2019, we organized for professionals (Public Prosecution's Office. Labour Inspectorate. Care and Support Organisations) a workshop on how to influence group dynamics among groups victims of (labour) exploitation, together with group dynamics expert Monique Bekker. This workshop was the result of the research conducted in 2017 and published in 2018. The objective of the workshop was for the participants to experience group dynamics, while at the same time discuss the feasibility and implementation of the recommendations in the report. This workshop was executed on behalf of the Coordination Center against Human Trafficking (CoMensha), that had received funding from the Dutch Ministry of Social Affairs and Employment (SZW).





# **Empowerment** & advocacy



#### Book: "And I live On"

In April 2019, we published the book "And I Live On: The Resilience of Rwandan Genocide Survivors of Sexual Violence" with Wolf Legal Publishers. The book includes testimonials of 15 women and men (including children of deceased mothers) about their lives 15 and 25 years after the genocide against the Tutsi in Rwanda. The book was launched, together with a photo-exhibition, 17 April 2019 at the Peace Palace in The Hague during the conference "The Genocide Against the Tutsi 25 Years On: What Lessons Has the World Learned from Rwanda in Prevention and Responses Genocides


Worldwide?", organized by the Rwandan Embassy in the Netherlands.

During this meeting we (together with Mama Lambert, the counselor of the women and men in the book) had also the opportunity to hand over the first copy of the book to Adama Dieng, the United Nations Special Advisor on the Prevention of Genocide. In Canada, where co-editors Samer Muscati and Sandra Ka Hon Chu are based, and photoexhibitions also took place. special website dedicated to the book was furthermore launched: www.and-i-live-on.com. In addition, we spoke several venues about the book, including for a group of students from Penn State University (US) at the Hogeschool of Amsterdam, organized by Edu Travel.



#### CRSV Network NL

In 2018, we set up the CRSV Network NL to provide NGOs based in the Netherlands (NL) and working on conflict-related sexual violence (CRSV) the opportunity to get an insight on each other's work and share knowledge on various issues related to sexual violence in conflict. The aim is to strengthening communication and cooperation between NGOs in the Netherlands working on the issue of CRSV. In 2019, the members of the CRSV Network NL included: (1) The Centre for African Justice, Peace and Human Rights; (2) Civitas Maxima; (3) Dr. Denis Mukwege Foundation; (4) Equator Foundation; (5) IMPACT: Center against Human Trafficking and Sexual Violence in Conflict; (6) Mukomeze Foundation; (7) Sterk Huis; (8) Women's Initiatives for Gender Justice; (9) IFHHRO: Medical Human Rights Network; and (10) Redress. The latter two organizations joined in 2019. The members meet twice a year and the meeting is hosted by one of the members. In 2019, we held the first meeting (18 April) at the Equator Foundation and War Trauma Foundation (Diemen) and the second meeting (7 November) at, again, the Equator Foundation (Diemen). During the second meeting we discussed a specific theme, which was introduced by some of the members, namely self-care for humanitarians.





#### Revenues 2019

At IMPACT, 10% of all income is set aside for 'empowerment projects'. In 2019, supported the International Red Cross with a donation for victims/survivors of human trafficking (3FM Serious Request), CoMensha's annual day for victims/survivors of human trafficking, and the Mukomeze Foundation with a ongoing contribution, in support of three Rwandan children who lost their mothers as a consequence of the genocidal sexual violence committed against them and one male survivor of genocidal sexual violence, in basic needs and/or education in university.
