# IMPACT: Center against Human Trafficking and Sexual Violence in Conflict

**Annual Report 2020** 

#### **Preface**

In 2020 we entered our fourth year of IMPACT: Center against Human Trafficking and Sexual Violence in Conflict. A year that was marked by the outbreak of COVID-19 and its world-wide consequences.

Luckily for us, it did not have an impact on our workload. The projects planned could continue, and we even managed to start with some new ones. But what did change was the way in which we conducted our work. Working from home rather than from the office led to cooperation from a distance. And most of our education and training moved from on-site to online programs. This required some flexibility and adaptation but also allowed for new possibilities and skills.

Apart from COVID-19, three impactful milestones stood out for us this year.

One was the impact that we managed to realise through the official launch of our own Journal on Human Trafficking, Enslavement and Conflict-Related Sexual Violence (JHEC), unique in its kind, with the first general issue being published in September 2021 and the first special issue on 'sexual terrorism' published in December 2021 (with Paris Legal Publishers).

Second was the contribution that we were allowed to make, in cooperation with MDF, in drafting the important and momentous fourth Dutch National Action Plan (NAP) 1325-IV (2021-2025), a partnership with joint commitments between various Dutch Ministries, the police and over 60 Dutch civil society organisations in implementing the UN Women, Peace and Security (WPS) agenda for the Netherlands. Being able to participate in the drafting of such an important document is the type of impact we had hoped and anticipated for when we started IMPACT a few years ago.

What, finally, stood out for us in 2020, was the impact we managed to generate by creating awareness about sexual terrorism. By publishing a joint article with Christophe Paulussen (T.M.C. Asser Instituut) in a top notch Journal, giving several lectures, contributing to webinars, having our special JHEC issue, having students write on the topic for their theses, and organising our own panel discussion, we managed to draw attention to - and getting the discussion moving on - the largely overlooked nexus between terrorism, human trafficking and conflict-related sexual violence.

We look with much confidence to 2021 and hope that also in the coming year we will be able to continue to impact our fields in various ways.

# Part 2: Annual Report 2020

#### **Achievements 2020**

#### Research & advice

#### Decent Work

At the end of 2019 we started with the implementation of several activities to contribute to realizing decent work in the Netherlands, as a way of preventing and responding to labour exploitation of migrant workers. This project continued in 2020 and is executed on behalf of the Coordination Center against Human Trafficking (CoMensha), that had received funding from the Dutch Ministry of Social Affairs and Employment (SZW).

#### Labour Exploitation

In 2020 the first steps were undertaken to set up a research project into the criminalization and enforcement of labour exploitation in the Netherlands. The research, that is executed partly on behalf of the Coordination Center Against Human Trafficking (CoMensha) and together with Tilburg University, aims at giving insight into the gaps that continue to exist in the successful investigation and prosecution of labour exploitation cases in the Netherlands.

#### Dutch National Action Plan 1325-IV (NAP1325-IV)

In 2020, we were involved as consultants, together with MDF, in the development of the Dutch National Action Plan (NAP) 1325-IV (2021-2025). NAP1325-IV is a partnership between the Ministries of Foreign Affairs, Defence, Education, Culture and Science, Justice and Security, the police and over 60 Dutch civil society organizations. The NAP1325-IV contains their joint commitments to implement UN Security Council Resolution 1325 and its successive resolutions, as well as other

international obligations and commitments on 'Women, Peace and Security' (WPS). With the NAP1325-IV, Dutch government and civil society organisations have committed to support women, men and youth in conflict affected countries, but also within the Netherlands, in their efforts for inclusive peace and security. Journal of Human Trafficking, Enslavement and Conflict-Related Sexual Violence
In 2019, we started with the preparations – together with Paris Legal Publishers – to set up a new multi- and interdisciplinary journal on the nexus between human trafficking, enslavement and conflict-related sexual violence: The Journal of Human Trafficking, Enslavement and Conflict-Related Sexual Violence (JHEC). JHEC became operational as of early 2020. Each year a general issue on one, two or all three crimes (summer) and a special issue on a specific theme (winter) will be published. For the 2020 special issue edition, the topic of 'sexual terrorism' was selected. This topic was chosen because of the vast increase of the systemic use by terrorist organizations of human trafficking and conflict-related sexual violence as a tactic of terrorism.



Article on 'Sexual Terrorism' with Journal of International Criminal Justice

In 2020, our joint article (with C. Paulussen) on 'sexual terrorism' with case studies on Boko Haram and Al-Shabaab was published with the *Journal of International Criminal Justice*. The United Nations Team of Experts on the Rule of Law and Sexual Violence in Conflict and the *Journal of International Criminal Justice* presented this special issue on 'Justice and Accountability for Sexual Violence in Conflict: Progress and Challenges in National Efforts to Address Impunity' as part of the commemoration of the 10-year anniversary of United Nations Security Council Resolution 1888 (2009). Resolution 1888 (2009) created the dedicated mandate of the Special Representative of the UN

Secretary-General on Sexual Violence in Conflict and the Team of Experts. The special issue includes many interesting contributions, amongst which ours. 
# Advice to Institutions and Interviews to Students/Professionals

In 2020, we provided advice to several organizations, including on sexual terrorism for the Global Counterterrorism Forum (GCTF) and on the Murad Code, a Global Code of Conduct for Documenting Conflict-Related Sexual Violence, for the Institute for International Criminal Investigations (IICI), the Preventing Sexual Violence in Conflict Initiative of the UK Government (PSVI) and Nadia's Initiative. In addition, we provided input on PhD proposals in the field of international criminal justice, victims' rights/needs and/or conflict-related sexual violence. Finally in 2020, we have given several interviews to professionals and students about human trafficking and/or conflict-related sexual violence.

#### **Education & awareness**

# Summer School at Tilburg University

In July 2020, we taught for the fourth time our two-week Summer School course at Tilburg University on preventing and addressing conflict-related sexual violence and human trafficking for 27 bachelor/master students representing 7 different nationalities and a multitude of disciplines. During these two weeks the opportunities and challenges in addressing both crimes were discussed from both a theoretical and practical perspective. Due to COVID-19 the course was offered online. Rather than visiting relevant institutions, several guest lectures were given, including by a translator/lawyer at the ICC Ongwen case, a psychologist from ARQ Centrum '45 who treats victims of THB and CRSV in the Netherlands, a researcher on terrorism and international crimes from the T.M.C. Asser Instituut and a member of the Dutch Armed Forces.

# Guest Lecture MVO

In 2020, we have offered a guest lecture to students of Graphic Lyceum Sint Lucas (Boxtel, the Netherlands (MBO-level)) on becoming and being social entrepreneurs.

## Bosnia and Rwanda project

In the year 2020, we started exploring, with Justice for Women (The Netherlands), Medica Zenica (Bosnia) and Solace Ministries (Rwanda), a project that would help us to gain more in-depth understanding of how victims/survivors in both Bosnia and

Rwanda have experienced sexual violence in conflict and how they, their families and society are dealing with it afterwards. Since both Rwanda and Bosnia have over 25 years of experience in dealing with trauma from mass violence – being the first countries coming from a conflict situation that received worldwide attention and for which the first ad hoc Tribunals were set up since World War II – many lessons can be learned from the impact of conflict-related sexual violence and their treatment approaches, not only for the countries concerned, but for countries all over the world dealing with this issue. The project is divided in three sub-programs: (1) sexuality education; (2) treatment; and (3) awareness raising through art to break through stigma. In 2021, we intend to make a start with the latter project.

## Participation in Conferences/Webinars

In 2020, we co-organized and/or participated in several conferences/webinars. In the following webinars, we had an active role as speakers:


# Training & capacity building

## TAIEX Kosovo

In 2020, we have joined a group of experts to Kosovo to assess the performance - specifically the protection of victims - by Kosovo authorities in the fight against trafficking in human beings in the context of Kosovo's application for EU membership and the Post-Visa Liberalization Monitoring Mechanism (PVLMM). TAIEX is the Technical Assistance and Information Exchange instrument of the European Commission. TAIEX supports public administrations regarding the approximation, application and enforcement of EU legislation as well as facilitating the sharing of EU best practices.

#### *Lecture Sexual Terrorism for Professionals*



## CRSV Network NL

In 2018, we set up the CRSV Network NL to provide NGOs based in the Netherlands (NL) and working on conflict-related sexual violence (CRSV) the opportunity to get an insight on each other's work and share knowledge on various issues related to sexual violence in conflict. The aim is to strengthening communication and cooperation between NGOs in the Netherlands working on the issue of CRSV. In 2020, the members of the CRSV Network NL included: (1) The Centre for African Justice, Peace and Human Rights; (2) Civitas Maxima; (3) Dr. Denis Mukwege Foundation; (4) Equator Foundation; (5) IMPACT: Center against Human Trafficking and Sexual Violence in Conflict; (6) Mukomeze Foundation; (7) Sterk Huis; (8) Women's Initiatives for Gender Justice; (9) IFHHRO: Medical Human Rights Network; and (10) Redress. The members meet twice a year and the meeting is hosted by one of the members. In 2020, we held both meetings (9 April and 19 November) online due to Covid-19. During the first meeting we discussed the topic of sexual violence against the male gender, which was introduced by several staff members and volunteers of the Centre for African Justice, Peace and Human Rights. During the second meeting we discussed

again a specific theme, namely 'sexual terrorism', which was introduced by Impact and a researcher from T.M.C. Asser Instituut.



#### Network

In 2020, we sustained our network. One of IMPACT's board members continued to be on the board of La Strada International (LSI), a leading European NGO Platform of NGOs that support trafficked persons at the local level throughout Europe. Further, we chair, on behalf of CoMensha, the quarterly Dutch Strategic meetings on Human Trafficking (SOM), which is a strategic meeting of NGOs in the Netherlands who provide support to victims of trafficking. In 2020, we further replaced the chair of the meeting of care coordinators for victims of trafficking twice.

## Signatory of the Dutch National Action Plan (NAP) 1325-IV

On 16 December 2020, we signed the Dutch NAP 1325-IV on Women, Peace and Security. This shows our commitment to implement UN Security Council Resolution 1325 and its successive resolutions on 'Women, Peace and Security'. See for more information on NAP 1325-IV above, under 'research & advice'.

#### **IMPACT**


What drives us to continue our work in combatting human trafficking and conflict-related sexual violence, is the impact that we generate. In 2020 we have had impact in several ways. We have witnessed the impact we generated through our research that has been picked up by policy makers, academics and others. For example, our research on labour exploitation in the Netherlands, the NAP1325-IV on WPS, our very own

Journal on Human Trafficking, Enslavement and Conflict-Related Sexual Violence, and our article on 'sexual terrorism'. We have furthermore witnessed the impact our education has on students of our Summer Schools. Several of these students have adjusted their further studies to continue studying in the domain of international justice/victims' rights and needs/THB and conflict-related sexual violence, while others found internships and jobs in these fields. Where possible, we support them with recommendation letters and advice in furtherance of their future studies or job applications. It is great to see that our goal of teaching the professionals of the future on the importance of tackling THB and CRSV, is becoming a reality. Being invited and recognized as members of an expert center on THB and CRSV and sharing our knowledge at high-level platforms, together with other experts, has also helped to move the discussion on topics such as THB, enslavement, CRSV, terrorism and its nexus further, for policy makers, students, professionals and the general public alike. Other impact that we have seen is with professionals working in the domain of terrorism, but not being much aware on the topic of 'sexual terrorism', but also with professionals working on THB in Kosovo, to enrich their understandings on 'sexual terrorism' and the protection of victims of THB even further, respectively. Finally, by being part of several networks, such as SOM, La Strada International and the CRSV Network NL, we strive to work together with other professionals in this field and to amplify the voices of survivors.

To keep our own energy level high, we also invest in ourselves. In 2020 we did this by inviting Kristen Jacobs to one of our 'Hay days'. During these days we look back on the previous year and forward to the next. Kirsten Jacobs (Iedereen aan Boord?!) gave us a coaching session on how we can achieve our aims more effectively: from thinking to doing.



Revenues 2020



At IMPACT, 10% of all income is set aside for 'empowerment projects'. In 2020, we supported the Mukomeze Foundation with an ongoing contribution, in support of three Rwandan children who lost their mothers as a consequence of the genocidal sexual violence committed against them and one male survivor of genocidal sexual violence, in basic needs, education in university and/or setting up their own business.
